Town Council Meeting

Minutes for Meeting May 9, 2011

The Sand Rock Town Council met for its monthly meeting on, Monday, May 9, 2011 at 6:30 p.m. in the Town Hall. Present were Mayor Bill Glenn, council members Julia Smith, Saprina Oliver, Gene Farmer, George Mackey, Ricky Mackey and Town Clerk, Melonie Garrett. Special guest was Randy Jones from Cherokee County Herald. Mayor Glenn called the meeting to order and Bud Mackey gave the opening prayer.

Mayor Glenn recognized the special guest and thanked them for attending the meeting.

After reviewing the minutes from the April 5, 2011 meeting the council approved the minutes on a motion by Ricky Mackey and seconded by Gene Farmer. Motion carried.

**Road Department**

Dead End Sign- Mayor Glenn informed the council that a lady that lived on the end of White Oak Street requested that a dead end sign be placed at the corner of Valley Street and White Oak Street. Ricky Mackey stated that the town did not have one and one should be ordered. Town clerk will order a sign.

**Park Department**

Walking Track – Saprina Oliver informed the council of a problem at the walking track. An area behind the fire department has broken away on the side and a hole is forming in the center of the track. Ricky Mackey suggested that cold patch be placed in the hole to make the necessary repairs.

**Building & Grounds**

Doors – Bud Mackey made a motion that the outside doors on the front of town hall be replaced with glass doors from Cherokee Glass. Saprina Oliver seconded the motion. Motion carried.

**Fire Department**

Fire Truck – Ricky Mackey informed the council that the new fire truck was arriving within the hour.

**Budget Department**

The monthly financial report and revenue/expenditure summaries were presented to the council. On a move by Saprina Oliver and seconded by Julia Smith the monthly financial reports were approved.

**Grants Department**

Nothing to report

Saprina Oliver will ask if there is any money available to help the town acquire any land and buildings.

**Old Business**

Power to Marquee – Mayor Glenn presented the three bids to add power to the marquee. Ricky Mackey made a motion to accept T H Electric at \$950.00 total cost. Julia Smith seconded the motion. Motion carried.

Jr Beta Project – Saprina Oliver made a motion to have the Jr Beta group re-stripe the town’s parking lot for \$250.00. Bud Mackey seconded the motion. Motion carried.

Meeting – Mayor Glenn wished to thank the council on the fast action that was taken on the sewer issue. He stated that he thought they had made the correct decision for the town at this time.

**New Business**

Generator – Mayor Glenn suggested to the council that a back up generator system be installed at town hall.

**Adjourned**

A motion was made by Bud Mackey and seconded by Gene Farmer to adjourn. Meeting adjourned at 7:25 pm.
