Town Council Meeting

Minutes for Meeting April 9, 2012

The Sand Rock Town Council met for its monthly meeting on Monday ,April 9, 2012 at 6:30pm in the Town Hall. Present were Mayor Bill Glenn, council members Julia Smith, Gene Farmer, George Mackey, Ricky Mackey and Town Clerk, Melonie Garrett. Council member Saprina Oliver was absent. Special guest were Randy Jones from the Cherokee County Herald, and Mary Bradley, Youth Leadership student. Mayor Glenn called the meeting to order and Bud Mackey gave the opening prayer.

Mayor Glenn recognized the special guest and thanked them for attending the meeting.

After reviewing the minutes from the March 12, 2012 meeting the council approved the minutes on a motion by Gene Farmer and seconded by Julia Smith. Motion carried.

Road Department

Overlook Street- Mayor Glenn reported that the highway department made repairs to the sides of Overlook Street and patched holes.

Building & Grounds

Walk Through – Mayor Glenn made a walkthrough of the park and fields areas. He asked that Pro Cut Lawn Care be contacted to spray weed killer around the fences and walking track. Ricky Mackey will contact Scott Stimpson about this.

The monthly financial report and revenue/expenditure summaries were presented to the council. On a move by Bud Mackey and seconded by Ricky Mackey the monthly financial reports were approved.

Ethics Commission filing – All members have completed their Ethics Commission filing requirements.

Door – Mayor Glenn will check on a new door for the storage area of town hall.

Paul Johnson Sign – Ricky Mackey informed the council that the Park sign was at Langley Construction. He will get with Langley Construction to get the sign back up in the park.

Jenkins Property – Mayor Glenn informed the council that Saprina Oliver had made the proposal of \$72,500.00. Mr. Jenkins made a counter offer of \$77,500. Mayor Glenn asked the council to consider another offer. Bud Mackey suggested that the issue be tabled until May meeting.

New Business

Science Department Clean up – Mayor Glenn read a letter to the council from Ms. Lindsey Oliver, science department teacher from Sand Rock School. She asked the council to help furnish trash bags and gloves for a project of road cleanup in the town’s limits. Ms. Oliver stated that she would be conducting the event on April 20th in an effort to help bring awareness to Earth Day Council member Gene Farmer made a motion to purchase the needed supplies for the science class project. Bud Mackey seconded the motion. Motion carried.

Tennis Net – Town Clerk informed the council that a new tennis net was needed. Ricky Mackey made a motion to purchase 2 nets. Julia Smith seconded the motion. Motion carried.

Cherokee County Museum – Mayor Glenn informed the council that the new director, Dave Crum, had asked that the Town of Sand Rock have a display in the museum. The item(s) could be about the history of the area or other important information that the Town would like to share about the area. Mayor Glenn asked the council to think about this and have ideas for next month’s meeting.

Insurance Award – Mayor Glenn read a letter to the council from the AMIC Insurance Company. The Town received the Gold award this last year.

Veteran Appreciation Medals- Mayor Glenn read a letter from Chief Justice Perry Hooper asking for assistance on a resolution to adopt a day of honor to veterans, displaying posters of the event, and monies for metals. No action was taking on this event and the item was tabled until the May meeting.
